

## **GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 66**

### **NOTICE OF REGULAR MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors (the “Board”) of Galveston County Municipal Utility District No. 66 (the “District”) will hold a regular meeting on **Thursday, September 18, 2025, at 12:00 p.m.**, at 6300 West Loop South, Suite 415, Bellaire, Texas 77401, said address being a meeting place of the District.

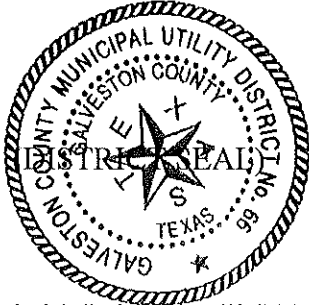
At this meeting, the Board will consider, discuss and adopt such orders, resolutions, or motions and take other direct or indirect actions as may be necessary, convenient, or desirable with respect to the following matters:

1. **Minutes:** Review and approve minutes of previous Board meetings.
2. **Auditor:** Consider approval of an audit report for the fiscal year ending May 31, 2025, and other secondary disclosure documents in accordance with SEC Rule 15c2-12.
3. **Public Comments:** Receive and consider comments and questions from the public (limited to 3 minutes per person). By state law, comments by the Directors on any item not on the agenda shall be limited to: (i) statements of specific factual information given in response to any inquiry; (ii) a recitation of existing policy in response to any inquiry; and (iii) a proposal to place the subject on a future agenda.
4. **Financial Advisor’s Report:**
  - a. Receive and act upon bids and proposals for the purchase of the District’s \$3,925,000 Unlimited Tax Bonds, Series 2025 (the “Series 2025 Bonds”), and the \$3,000,000 Unlimited Tax Park Bonds, Series 2025A (the “Series 2025A Park Bonds”);
  - b. Adopt a resolution authorizing the issuance, sale and delivery of the District’s Series 2025 Bonds and a resolution authorizing the issuance, sale and delivery of the District’s Series 2025A Park Bonds;
  - c. Approve and authorize distribution of a Final Official Statement in connection with the District’s Series 2025 Bonds and Series 2025A Park Bonds;
  - d. Approve and execute a Paying Agent/Registrar Agreement in connection with the District’s Series 2025 Bonds and Series 2025A Park Bonds; and
  - e. Consider and act upon any other matters concerning the Series 2025 Bonds and the Series 2025A Park Bonds.
5. **Tax Assessor/Collector’s Report:** Receive the Tax Assessor-Collector’s report, including:
  - a. Approving checks on tax account;
  - b. Receive report on the status of delinquent tax accounts; and
  - c. Approve tax refunds and requests for waiver of delinquent penalties and interest.

6. **Bookkeeper's Report:**
  - a. Receive the Bookkeeper's report, including financial and investment reports, and authorize the payment of invoices presented.
7. **Attorney's Report:** Receive the Attorney's report, including:
  - a. Consider requests for annexation of land into the District and authorize all appropriate action, including acceptance of annexation petitions from landowners, execution of petitions to the City of Texas City for consent to annexation, adoption of Order(s) Adding Land into the District and approval of Amendment(s) to District Information Form;
  - b. Approval of utility commitment letters;
  - c. Approval of developer reimbursement agreements;
  - d. Approval of resolutions to the Texas Commission on Environmental Quality regarding the release of escrowed funds, the use of surplus funds, and/or a change in use of funds; and
  - e. Approval of audits and/or appraisals for reimbursement to developers from the proceeds of the sale of the District's bonds or other District funds; and
  - f. Consider proposals for the renewal of the District's insurance policies expiring October 1, 2025.
8. **Engineer's Report:** Receive the Engineer's report, including:
  - a. Authorize and/or concur with the design, advertisement for bids and/or award of contracts for the construction of water, sanitary sewer and drainage or other facilities within the District;
  - b. Approve and/or concur in the approval of pay estimates and change orders on current construction projects within the District;
  - c. Accept site and/or easement conveyances for facilities constructed or to be constructed for or on behalf of the District;
  - d. Grant or consent easements over District property; and
  - e. Review and approve bond application reports.
9. **Developers' Reports:** Receive reports from developers of land within the District.
10. **Executive Session:** Convene in closed executive session to deliberate, review, and discuss any matter as authorized under the Texas Open Meetings Act, Chapter 551, Texas Government Code.
11. **Other Matters:** Other matters that may come before the Board.

12. Adjourn.
